



# Charter

*of the European Union Delegation to the  
G20 Women20 and G7 Women7 Official Stakeholder Engagement Groups  
& Digital Leadership Institute International ASBL*

The European Union Delegation to the G20 Women20 and G7 Women7 official stakeholder engagement groups (“EU Delegation”) is hereby brought into effect with the present Charter.

1. **Mission:** The Mission of the European Union Delegation to the G20 Women20 and G7 Women7 is to represent European Union feminist civil society toward G20 Women20 and G7 Women7 official stakeholder engagement groups, and to promote full social, political and economic agency of girls and women, in all their diversity, in the European Union, in G7 and G20 countries, and around the world.
2. **Activities:** The European Union Delegation to the G20 Women20 and G7 Women7 official stakeholder engagement groups realises its Mission through the following Activities:
  1. **Advocacy:** Advocating at the highest level in public and private spheres on matters reflecting the Mission of the Delegation;
  2. **Engagement:** Engaging public and private sector actors to support the Mission of the Delegation;
  3. **Thought-leadership:** Demonstrating individual and delegation-wide thought-leadership on matters supporting the Mission of the Delegation; and
  4. **Other:** Carrying out other activities consistent with the Mission of the Delegation.
3. **Bylaws:** Rules central to the functioning of the European Union Delegation to the G20 Women20 and G7 Women7 official stakeholder engagement groups are captured in a set of Bylaws and their Annexes, of which the present Charter makes up part, agreed in accordance with Clause 3 Article 3 of Digital Leadership Institute ASBL articles of association.
4. **Amendments:** The present Charter may be modified or amended per Digital Leadership Institute ASBL articles of association, with written agreement of two or more DLI board members, one of whom is DLI President and ex officio Head of European Union Delegation to the G20 Women20 and G7 Women7 official stakeholder engagement groups.
5. **Jurisdiction:** The present Charter is governed by Clause 3 Article 3 of the articles of association of the Digital Leadership Institute ASBL, legal representative of the EU Delegation, pursuant to Belgian law 27.06.1921 giving legal personality to non-profit associations, modified by the law of 02.05.2002:

*Art. 3. Actions de sensibilisation et de défense de la mission de DLI :*

*Mener des actions de conscientisation et de défense de la mission pour créer les conditions sociales, politiques et économiques qui favorisent l'émancipation des jeunes filles et des femmes... Cela comprend la direction et la gestion des délégations de l'Union européenne auprès du G20 Women20, du G7 Women7 et d'autres groupes intergouvernementaux et multilatéraux officiels d'engagement des parties prenantes représentant la société civile féministe de l'UE, tels que régis par un ensemble de règles opérationnelles propres à cette entreprise dont la constitution et les amendements sont promulgués par accord écrit de deux administrateurs DLI ou plus, dont un est le président DLI, ce dernier étant également, ex officio, chef de délégation pour l'Union européenne.*
